### **EXECUTIVE SUMMARY**

As part of the preparation for the Multi-year Budget Process, the Public Service conducted a preliminary review of services provided by the City with respect to whether or not there was a legislated requirement to provide the applicable service.

The attached summary provides information with respect to whether or not there is a legislative requirement or other reason for provision of a service for the use of Council during the budget process.

#### RECOMMENDATION

That the preliminary review of service areas, as part of the multi-year process, be received as information.

#### REASON FOR THE REPORT

On March 20, 2019, as part of the 2020 multi-year budget process, recommendation 1. V.i.a. of the Council Adopted 2019 Budget directed the Chief Administrative Officer to report back to the appropriate committee of Council with a review of the City's core service delivery responsibilities under the City of Winnipeg Charter (the "Charter") and any other relevant legislation.

On December 3, 2019, Executive Policy Committee granted an extension of up to 90 days for the Winnipeg Public Service to report back.

On March 17, 2020, Executive Policy Committee granted a further 60-day extension for this report.

The Public Service was granted a further 60-day extension by Executive Policy Committee on May 22, 2020.

### **IMPLICATIONS OF THE RECOMMENDATIONS**

The results of the review of municipal services provide additional information for the use of Council in the multi-year budget process.

#### HISTORY/DISCUSSION

As part of the multi-year budget process, Council directed the Public Service to review service delivery responsibilities of the City of Winnipeg.

#### Discussion

During 2003, the City of Winnipeg Legal Services department conducted a review of municipal services with respect to whether or not there was a legislative requirement to provide each of those services. This review did not take into account any service delivery obligations as a result of contracts or collective agreements and, given additional changes to legislation, is considered out of date.

In preparation for presentation of the multi-year budget process to Council for approval, the Chief Financial Officer directed the Public Service to conduct a review of all services provided by the City of Winnipeg and classify them as either legislatively required by the City of Winnipeg Charter or other type of legislation, and other essential and discretionary services. With the launch of the 2020 multi-year budget on October 18, 2019, the results of the review were posted to the city website. A further review was conducted by the Legal Services department and is incorporated into the attached Appendix 1.

### Service Delivery Responsibilities

The Charter does not specifically define City of Winnipeg core service delivery responsibilities. It, and other relevant legislation, as well as the common law, establish a legal framework within which the City is required or permitted to deliver specific services, which are interpreted as core service delivery responsibilities for the purpose of this report.

It should be noted that, even though there may be no legislative requirement to provide a service, delivery of the service may be implied. As an example, there is no legislated requirement to establish a 911 call centre, but in order to effectively provide emergency response services, establishment of the call centre is necessary.

Appendix 1 uses the following common notes in describing the basis for service delivery responsibility conclusion. As noted above, legislated services include considering more than legislation.
